The following Restated Articles of Incorporation, duly adopted pursuant to the authority and provisions of the Wisconsin Business Corporation Law, Chapter 180 of the Wisconsin Statutes, supersede and take the place of the heretofore existing Articles of Incorporation of Aunt Nellie's Farm Kitchens, Inc. and all amendments thereto:

ARTICLE I

The name of the corporation is Ehmann Olive Company.

ARTICLE II

The aggregate number of shares which the corporation shall have authority to issue is Thirty-six Thousand (36,000), consisting of Thirty-five Thousand (35,000) shares of common stock with a par value of \$1.00 per share and One Thousand (1,000) shares of preferred stock with no par value.

ARTICLE III

Action required or permitted to be taken at a shareholders' meeting may be taken without a meeting by shareholders who would be entitled to vote at a meeting those shares with voting power to cast not less than the minimum number or, in the case of voting by voting groups, numbers of votes that would be necessary to authorize or take the action at a meeting at which all shares entitled to vote were present and voted.

ARTICLE IV

The number of directors constituting the Board of Directors of the corporation shall be fixed by or in the manner provided by the by-laws.

ARTICLE V

The address of its registered office is 640 Caughlin Road, Clyman, Wisconsin 53016. The name of its registered agent at such address is Roy C. LaBudde.
