**RELEASE OF
GRANT OF SECURITY INTEREST
IN TRADEMARKS**

WHEREAS, Total Warehousing, Inc. (the "Pledgor") is the owner of the trademarks and service marks listed on Schedule A attached hereto, which marks are registered or have pending registrations in the United States Patent and Trademark Office as set forth on Schedule A attached hereto (all such trademarks, service marks, registrations and applications, collectively, the "Trademarks"); and

WHEREAS, in order to secure certain indebtedness, the Pledgor entered into a Pledge and Security Agreement (as amended, modified, restated or supplemented from time to time, the "Security Agreement"), dated as of June 14, 2004, in favor of Wachovia Bank, National Association, as Administrative Agent (the "Administrative Agent"), and pursuant thereto the Pledgor agreed with Comerica Bank, as Collateral Agent (the "Collateral Agent") and the Administrative Agent to execute and deliver an Assignment and Grant of Security Interest in Trademarks (the "Trademark Assignment") as recorded in the United States Patent and Trademark Office in Reel 2871, Frame 0917 on June 15, 2004, pursuant to which Pledgor granted to the Collateral Agent, according to the terms of the Security Agreement, a security interest in all of its right, title and interest in and to the Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent does hereby release and relinquish, and does hereby reassign to the Pledgor, without representation or warranty, all of the Collateral Agent's right, title and interest in and to the Trademarks, and the use thereof, together with all proceeds and products thereof and the goodwill of the businesses symbolized by the Trademarks, and does hereby agree that the filing of the Trademark Assignment in the United States Patent and Trademark Office as aforesaid may be removed of record.
