RELEASE OF SECURITY AGREEMENT

This RELEASE dated as of January 31, 2007, is made by JPMORGAN CHASE BANK, N.A., as Agent (as defined below) for the Lenders. All capitalized terms used herein that are defined in the Existing Credit Agreement referred to below and that are not otherwise defined herein shall have the respective meanings ascribed thereto in the Existing Credit Agreement.

Reference is made to (a) the Amended and Restated Credit Agreement dated as of June 30, 2005 (the "Existing Credit Agreement"), among TRAVELCENTERS OF AMERICA, INC., a Delaware corporation (the "Borrower"), the financial institutions party thereto, as lenders, and JPMORGAN CHASE BANK, N.A. (f/k/a JPMorgan Chase Bank), as administrative agent (in such capacity, the "Agent"), and (b) the Amended and Restated Security Agreement dated as of June 30, 2005 (the "Existing Security Agreement"), among the Borrower, TA OPERATING CORPORATION, a Delaware corporation ("TA"), TA FRANCHISE SYSTEMS INC., a Delaware corporation ("TAFSI"), TA LICENSING, INC., a Delaware corporation ("TA Licensing"), TA TRAVEL, L.L.C., a Delaware limited liability company ("TA Travel", and, together with TA, TAFSI, TA Licensing and the Borrower, the "Grantors"), and JPMORGAN CHASE BANK, N.A., as collateral agent, (c) the Trademark Security Agreement dated as of December 1, 2004 (the "December 2004 Trademark Security Agreement"), among the Grantors and the Agent and (d) the Trademark Security Agreement dated as of June 30, 2005 (the "June 2005 Trademark Security Agreement" and, together with the Existing Security Agreement and the December 2004 Trademark Security Agreement, the "Security Agreements") among the Grantors and the Agent.

Pursuant to the Security Agreements, among other things, the Grantors granted a security interest to the Agent, for the benefit of certain parties named therein, in, among other things, the trademarks and trademark applications of the Grantors set forth on Annex I hereto (the "Trademarks"), which security interest was recorded with the United States Patent & Trademark Office.

In connection with the termination of the Existing Credit Agreement, the Borrower has informed the Agent of its desire to obtain the release of all rights, title and interest of the Agent in and to the Trademarks granted under the Security Agreements.

Accordingly, for good and valuable consideration, receipt of which is acknowledged, the Agent hereby releases all rights, title and interest (including, without limitation, security interests) in and to the Trademarks.

IN WITNESS WHEREOF, the Agent, by its duly authorized Officer thereof, has caused this Release to be duly executed as of the date set forth above.
