WHEREAS, ESPI Trading Inc. filed a federal intent to use trademark application with the United States Patent and Trademark Office on October 6, 2005, Application Serial No. 78/727,527, for the mark ETIQUETA AZUL for carbonated mineral water and flavored soft drinks; and



This assignment is worldwide in scope. This is an assignment of all of ESPI's rights, and the accompanying portion of the business and goodwill symbolized by the Marks, which concerns sparkling mineral water and flavored soft drink products.
