ASSIGNMENT OF TRADEMARKS

THIS ASSIGNMENT is made as of the 1st day of March 2004, between Minnesota Public Radio, a Minnesota corporation, having a principal place of business at 45 East Seventh Street, Saint Paul, Minnesota 55105 (the "Assignor") and Saga Communications of Michigan, LLC, a Delaware limited liability company, having a principal place of business at 73 Kercheval Avenue, Grosee Point Farms, Michigan 48236, as assignee of the rights and obligations of Saga Broadcasting, LLC ("Saga Broadcasting") under the Asset Purchase Agreement dated January 23, 2003 ("Purchase Agreement") by and between Assignor and Saga Broadcasting (the "Assignee").

WHEREAS, the Assignor is the owner of the trademarks listed on Schedule A hereto (the "Trademarks").

WHEREAS, the Assignor has agreed to assign the Trademarks to the Assignee, and the Assignee has agreed to accept such assignment.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor does hereby sell, assign, set over and transfer to the Assignee, its successors and assigns, its entire right, title and interest in and to the Trademarks and any and all United States Patent and Trademark Office registrations and applications therefore as set forth herein, together with the goodwill of the business pertaining to the Trademarks, the same and the rights of the Assignor to be held and enjoyed by the Assignee for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives, at common law and/or to the full end of the term or terms for which registration of the Trademarks may be granted or renewed, to the same extent as the Assignor would hold and enjoy if this Agreement and sale had not been made; together with all claims for damages by reason of past infringement of the Trademarks with the right to sue for and collect the same for its own use and benefit, and for the use and on behalf of its successors, assigns or other legal representatives.

The Assignor agrees to fulfill its obligations under Section 8.3 of the Purchase Agreement, and also agrees, at the request and expense of the Assignee, to testify in any legal proceedings, sign all lawful papers, make all lawful oaths, and generally use reasonable efforts to aid said Assignee, its successors and assigns, to obtain, maintain and enforce protection for said Trademarks in the United States.

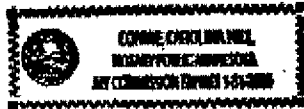
