THIS DEED OF ASSIGNMENT is made the ^b day of September 2004

BETWEEN:

- (1) **OASIS STORES LIMITED**, a company incorporated in England and Wales under No. 2571150 whose registered address is at 13-16 Lakeside, Stanton Harcourt, Witney, Oxon OX29 5TR (“the Assignor”); and
- (2) **DECKPAGE LIMITED** a company incorporated in England and Wales under No. 5182583 whose registered address is at 98 Hampstead Way, London NW11 7XY (“the Assignee”).

1. INTRODUCTION

- 1.1 Pursuant to a corporate transaction it was agreed that the Assignor would transfer the trade marks identified in the Schedule attached hereto (the “Trade Marks”) and the goodwill attaching to them, to Mr Maurice Bennett or such third party as Mr Bennett shall nominate, Mr Bennett has nominated the Assignee.
- 1.2 The Assignor has agreed to assign the Trade Marks to the Assignee and the Assignee has agreed to accept the assignment of the Trade Marks.

2. ASSIGNMENT OF TRADE MARK

- 2.1 The Assignor hereby assigns to the Assignee with full title guarantee all right title and interest in and to the Trade Marks, including all statutory and common law rights attaching to the Trade Marks and the right to take action in respect of past infringements or passing off of the Trade Marks and to retain any damages obtained as a result of such action.
- 2.2 The Assignor confirms that this Assignment is made with the goodwill attaching to the Trade Marks and the goodwill of the project in relation to which the Trade Marks have been used by the Assignor.
- 2.3 The Assignor shall at the request and expense of the Assignee do all acts and execute all documents in order to vest the Trade Marks in the Assignee.

3. LAW & JURISDICTION

- 3.1 This Agreement and the relationship between the parties will be governed by, and interpreted in accordance with, the laws of England and Wales.


3.2 The parties agree that the High Court of England is to have non-exclusive jurisdiction over this Agreement.
