Release of Lien on Trademarks

This Release of Lien on Trademarks (the "Release"), dated as of January, [] 2007 is made by Societe Generale, a French corporation, as agent ("Agent") for the financial institutions party to the Senior Secured Credit Agreement dated as of January 14, 2005 among Interstate Operating Company, L.P., the Agent and the other parties thereto, in favor of Bridgestreet Corporate Housing Worldwide, Inc., a Delaware corporation and Interstate Operating Company, L.P. (collectively, the "Grantors").

WHEREAS, Grantors entered into an Amended and Restated Security Agreement, dated as of January 14, 2005 and recorded in the United States Patent and Trademark Office as of February 9, 2005 at Reel 3119, Frame 0457, pursuant to which Grantors granted to the Agent a security interest in and lien on all right, title and interest of the Grantors in certain trademarks, including the trademark registrations and applications set forth on Schedule A attached hereto (the "Released Trademarks"), in addition to other trademark registrations and applications which are not a subject of this Release (the "Unreleased Trademarks"), to secure the performance of certain obligations (the "Obligations");

WHEREAS, the Released Trademarks are no longer included in the collateral securing the performance of the Obligations, and Grantors have requested that the Agent release any and all interest it may have in the Released Trademarks, and the Agent has agreed to do so.

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby release, relinquish and discharge its security interest in, to and under the Released Trademarks, but does not release, relinquish and discharge its security interest in, to and under any of the Unreleased Trademarks.
