
WHEREAS, Assignor has agreed to convey, transfer and assign the Trademarks and all associated goodwill in the Trademarks to to Assignee;

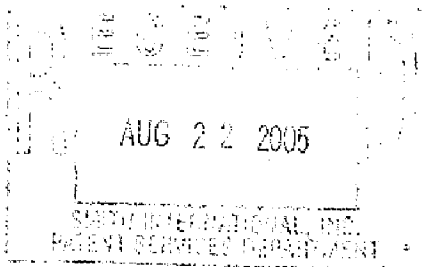
