
WHEREAS, ASSIGNEE is acquiring that portion of ASSIGNOR's business to which the Marks and the Property pertain, which business is ongoing and existing.



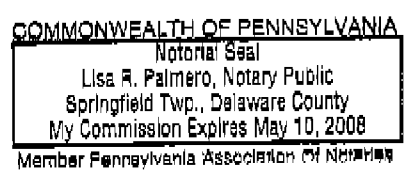
