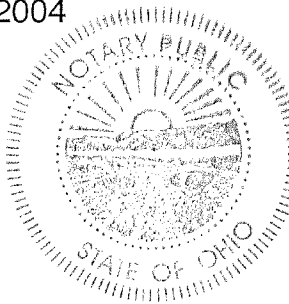

ASSIGNMENT OF TRADE MARKS

This ASSIGNMENT is made the 19<sup>th</sup> day of May 2004 ,

BETWEEN:

- (1) **THE LUBRIZOL CORPORATION** a corporation of State of Ohio, USA having its principal place of business at 29400 Lakeland Blvd, Wickliffe, OH, 44092 (the "Assignor"); and
- (2) **LUBRIZOL LIMITED**, a corporation of the United Kingdom, having its principal place of business at Dock Road South, Bronborough, Wirral, Merseyside, CH 62 4SH, United Kingdom (the "Assignee").

WHEREAS:

- (A) The Assignor is the proprietor of certain registered and unregistered trade marks and is entitled to the benefit of certain trade mark applications.
- (B) The Assignor agrees to assign the said registered and unregistered trade marks and trade mark applications on the terms and conditions hereof.

IT IS HEREBY AGREED:

**1. DEFINITIONS**

- 1.1. In this Assignment, including its Recitals and Schedules, the following terms shall have the following meanings, unless the context otherwise requires:

"the Applications" means the trade mark applications listed in Schedule 2;

"the Registered Trade Marks" means the registered trade marks listed in Schedule 1;

"the Unregistered Trade Marks" means the unregistered trade marks listed in Schedule 3;

"the Trade Marks" means the Unregistered Trade Marks and the Registered Trade Marks and the Applications or any one of them;

- 1.2. In this Assignment:

- 1.2.1. the singular includes the plural and vice versa;

- 1.2.2. a reference to a Recital, Clause or Schedule is to a recital, clause or schedule of or to this Assignment;

- 1.2.3. all Recitals and Schedules form part of this Assignment;

- 1.2.4. a reference to any party to this Assignment or any other document or arrangement includes that party's executors, administrators, substitutes, successors and permitted assigns;

- 1.2.5. headings are for convenience only and shall not affect interpretation.

## 2. ASSIGNMENT

- 2.1. For payment of Three million Eight Hundred Fifty Two Thousand British Pounds (£3,852,000) (receipt of which is hereby acknowledged by the Assignor), effective on the date and year first written above, the Assignor hereby assigns to the Assignee:
- 2.1.1. its entire right, title and interest in and to the Registered Trade Marks and the Applications including any copyright it owns in the Registered Trade Marks and the Applications and its entire right, title and interest in and to the goodwill associated with, symbolized by or attaching to the Registered Trade Marks and the Applications (but no other goodwill); and
  - 2.1.2. its entire right, title and interest (if any) in the goodwill associated with, symbolised by or attaching to the Unregistered Trade Marks but for the avoidance of doubt only the goodwill relating to the business in the goods for which the Unregistered Trade Marks are used, being the goods listed opposite the Unregistered Trade Marks in Schedule 3 (but no other goodwill); and
  - 2.1.3. all Assignor's rights and powers arising from or attaching to its right, title and interest in and to the Trade Marks including, without limitation, the benefit of the Applications, with the intent that when the Applications are granted the registrations will vest in the Assignee and the right to institute and maintain proceedings for infringement or wrongful use of the Trade Marks or for passing off whether occurring prior to the date hereof or hereafter; and
  - 2.1.4. the Assignors right (if any) to apply for, prosecute and obtain registered trade mark protection throughout the world in respect of the Trade Marks, to the intent that the grant of any protection thereon will be in the name of and vest in the Assignee.

## 3. EXCLUSION OF WARRANTIES

Without prejudice to any other written agreements between the parties, no warranties, representations, conditions or undertakings are given in or under this Assignment by the Assignor as to the Trade Marks whatsoever, including, without limitation, as to its title to them, or as to the Assignee's use of them, including as to infringement of third party rights and any warranties, terms, representations or conditions which may have been otherwise implied by law, statute or otherwise into this Assignment relating to the Trade Marks or otherwise are hereby expressly excluded to the fullest extent permitted by law.

## 4. GOVERNING LAW

This Assignment shall be governed by and construed in accordance with the procedural and substantive laws of the State of Ohio.

5. COUNTERPARTS


