BETWEEN:

- (1) **PARTNERS FOR GROWTH, L.P.**, a Delaware limited partnership whose principal office is at 180 Pacific Avenue, San Francisco, CA 94111 ("PFG");
- (2) **LIVENOTE TECHNOLOGIES LIMITED** a company registered in England under number 02540915 whose registered office is at c/o Hamilton Field Limited, 2nd Floor, Ely Place, London EC1N 6SD (the "Company"); and
- (3) **LIVENOTE, INC.**, a Delaware corporation whose principal office is at 221 Main Street, Suite 1250, San Francisco, CA 94105 (the "Subsidiary").

WHEREAS

- (1) By the security documents more particularly described in Schedule One to this Deed (together, the "Security Documents"), certain undertaking, property and assets of each of the Company and the Subsidiary (together, the "Assets") were charged to PFG to secure the liabilities of each of the Company and the Subsidiary pursuant to the Security Documents to PFG.
- (2) In consideration of the full and complete discharge of all the liabilities of each of the Company and the Subsidiary to PFG pursuant to the Security Documents, PFG has agreed to release the Assets from the Security Documents, and any and all other liens, charges, security interests, charges, mortgages, pledges or other similar rights in favour of PFG in and to any assets or properties of the Company and the Subsidiary.

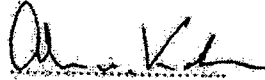
NOW THIS DEED WITNESSES as follows:

In consideration of the full, complete and indefeasible discharge of all the liabilities of each of the Company and the Subsidiary to PFG pursuant to the Security Documents, whether actual, contingent, sole, joint and/or several or otherwise, PFG hereby irrevocably and unconditionally surrenders, releases and reconveys:
 - 1.1 all of the Company's rights to and interests in and the undertaking, property and assets of the Company to the Company; and
 - 1.2 all of the Subsidiary's rights to and interests in and the undertaking, property and assets of the Subsidiary to the Subsidiary,

in each case free and clear of all security rights and interests constituted by the Security Documents, and any and all other liens, charges, security interests, charges, mortgages,
