WHEREAS, the Marks were assigned by Frymaster Holding Company, a Delaware corporation, to Frymaster LLC, a Louisiana limited liability company, executed October 31, 2005, as recorded at Reel/Frame No. 3197/0682; and

WHEREAS, Frymaster desires to correct the ambiguity in the chain of title in which Welmoore Industries, Inc., assigned the Marks to The Frymaster Corporation, a Delaware corporation, executed December 20, 1983, as recorded at Reel/Frame No. 0482/0460.


