**In the year two thousand two, the nineteenth day of the month of December – 19 December 2002 – in my office in Arezzo,**

**the following appeared before me, Doctor GIOVAN BATTISTA CIRIANNI, a notary residing in Arezzo, with an office on Via Ser Petraccolo No. 7, listed in the District Registry of Notaries in Arezzo, without the intervention of witnesses opposing them, with common agreement between them and with my consent, representatives who meet all the requirements of the law,**

**1) LAURA LAPINI, born in Arezzo on 9 September 1967 and residing in Arezzo, Via G. Severi No. 155, who is intervening in the present case not on her own account, but in her capacity as special prosecutor for the company “GENNY S.P.A.” [joint stock company], which has headquarters in Ancona, Via D. Albertini No. 12, and capital amounting to 3,450,000.00 euros, and is listed in the Ancona Register of Businesses, with the tax code registration number 00091750422 and authorized by a special mandate issued by the Chairman of the Board of Directors of the company, Dr. Marco Salomoni, born in Milan on 12 July 1954 and residing in Milan, Via Domenichino No. 14, by a document authenticated by the signature of Notary Lodovico Barassi, of Milan, on 12 December 2002, Report No. 59843, which is attached to the present document as item “A” and which is an integral and substantial part of the document. The reading of this item is omitted at the request of the persons involved and with my consent;**

**2) FABRIZIO CARETTA, born in Ivrea on 7 February 1966 and residing in Biella, Via Carta No. 18, who is intervening in the present case not on his own account, but in his capacity as a special prosecutor for the company “IPI ITALIA S.P.A.”, which has its headquarters in Milan, Via A. Fogozzaro No. 28, and capital amounting to 2,300,000.00 euros, and is listed in the Milan Register of Businesses, with the tax code registration number 12251190156, and is authorized by a special mandate issued by the managing director of the company, Dr. Francisco Antonio Truglia, born in Buenos Aires (Argentina) on 9 November 1964, residing in Arese, Via G. Matteotti No. 21, by a document authenticated by the signature of Notary Francesco Cavallone, of Milan, on December 11, 2002, Report No. 187907, which is**

attached to the present document as item “B” and which is an integral and substantial part of the document. The reading of this item is omitted at the request of the persons involved and with my consent.

On the basis of personal identification, qualifications and powers, I am indisputably the notary of the persons involved and they themselves have requested my services in drafting the present document, as follows:

#### Article 1

The GENNY S.P.A. company, represented as stated, by the present document, is cedes and transfers to the IPI Italia S.P.A., which, represented as stated, accepts and acquires the branch of the company in the Commune of Ancona which has the task of managing and marketing the “GENNY” Brand, as well as its license.

#### Article 2

The transfer includes all the personal property and economic units that supply and furnish the company, specifically:

- The “Genny“ Brand as it is registered and deposited in the means and times resulting from the list that is attached to the present document as item “C” and is an integral and substantial part of the document. The reading of this item is omitted at the request of the persons involved and with my consent;
- The photographic and advertising archives dealing with this brand;
- The customer register;
- The Internet domain [www.Genny.com](http://www.Genny.com) as it was registered by the Winsome Italia company on 5 January 1999;

The monetary value of the activity that the company carries out is equal, on the whole, to 28,405,000.00 (twenty-eight million, four hundred five thousand, decimal point, zero, zero) euros.

#### Article 3

In accordance with Article 2558 of the Civil Code, the company that is taking over another company replaces the following in the contracts dealing with the branch of the company transferred:

- The license contract stipulated by the “GENNY MODA S.P.A.” company on April 2 1991, as extended and integrated;

- The license contract stipulated by the “LUXOTTICA S.R.L. [Ltd.]” company on 31 December 2001;
- The license contract stipulated with the “ITALSETA 2000 S.r.l.” company on 20 December 2000 and extended on 7 September 2001;
- The license contract stipulated with the “Henkel S.p.A” company, a division of Morris Profumi on the date of 16 March 1998;
- The license contract stipulated with the “GIVUESSE S.r.l.” company on 25 September 2000;
- A giro account existing with the “Prada Industrial S.p.A.” company, with relative balance on this day in which there is a debit showing that the transferred company is responsible for equal to Euro 11,139,000.00 (eleven million, one hundred thirty-nine thousand comma zero zero);
- A giro account existing with “Genny Moda 2 S.p.A” with a relative balance on this day, in which there is a debit that the transferred company is responsible for equal to Euro 16,800,000.00 (sixteen million, eight hundred thousand comma zero zero);

The transferee declares having received from the transferor a copy of all the documentation relative to the contracts and the above mentioned relations, and therefore having clear knowledge of their current situation; on the other hand, the transferor declares and guarantees to having supplied to the transferee company all the documentation in its possession regarding the contracts and the relations listed above and that there are no other relations or contracts relative to the business branch transferred other than those mentioned above.

#### Art.4

Except for the credits and debits pertaining to the contracts and checking accounts held by the transferred company and described above for which the transferee has specifically acknowledged responsibility, any other company credits and debits will be excluded and the transferor company will remain responsible for such and will be obligated to reimburse the transferee for any amount it may have to disburse to creditors of the company pursuant to art. 2560 of the civic code.

#### Art. 5

This transfer is being implemented for the total price of Euro 466,000.00 (four hundred sixty-six thousand euros and zero cents); an amount that the transferee is required to pay within 90 (ninety) days from this day.

#### Art.6

Furthermore, this transfer is carried out and accepted in accordance to the following agreements and conditions:

- the transferor guarantees full title, ownership, liberty and availability of the division transferred in the contract and that the division be free of any liens, privileges, attachments and foreclosures;
- The transferee declares that it is included in the possession of the transferred company as of today and of having received all the pertaining documentation;
- The economic effects of the implemented transfer, in regards to the use of the company transferred, all rights take place on this date and this date forward they will be in favor of the transferee and the latter will take in all the profits and will be responsible for all the expenses, the relative liabilities and in particular any type of tax concerning the business operation;
- The transferor declares that there are no subordinate employees and this clause, if they should ever exist, could be reason for termination of this contract in accordance to art. 1456 of the civic code;
- The transferor declares that it is not in a state of insolvency nor in a state of “ceased payments” and that it has not had bills of exchange protested and/or injunctions and that it is up-to-date with payment of all taxes and fees;
- The transferor offers, as of now, any type of assistance concerning the transfer of licenses or administrative permits of any type that are required, eventually, by the laws in force to operate the company that has been transferred and also to use forms of advertising that are necessary or suitable for the implementation of the present contract, giving the party that has transferred a branch the same authorization to use all the practices that are necessary to advertise transfers in its own name.

#### Article 7

All transcriptions and publicity in the case are authorized.

#### Article 8

The expenses of this document and subsequent related expenses are borne by the party transferring the branch.

The notarial document, consisting of two pages, occupies Page 7 up to this point, written partly by machine in indelible ink by a person whom I trust and partly by me, the notary, by hand and it is signed in the margin by the representatives of the companies and by me.

I, the notary, gave the present document to the representatives to read. In response to my question, they told me that everything was in accord with their wishes.
