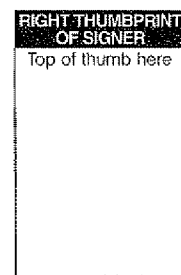

## ASSIGNMENT OF A TRADEMARK

WHEREAS, Michael C. Donaldson, an individual, whose address is 9220 Sunset Boulevard, Suite 224, Los Angeles, California 90069, has adopted, used, and is using the mark WISH WANT WALK in commerce as early as May 11, 2004; and

WHEREAS, MWH Global, Inc., and Michael C. Donaldson are desirous of acquiring said common law mark WISH WANT WALK and pending trademark application 78/444651 and mark as joint owners;

NOW therefore, for good and valuable consideration, the receipt of which is hereby acknowledged:

(1) MWH Global, Inc., hereby grants, transfers, assigns, sells, conveys, and relinquishes to MWH Global, Inc., and Michael C. Donaldson, as joint owners, and their respective successors and assigns, the entire title, right, interest, ownership, goodwill, and all subsidiary rights in and to the mark WISH WANT WALK and the application 78/444651 therefor, including, but not limited to, the following:

(a) the right to sue and recover for, and the right to profits or damages due or accrued arising out of or in connection with, any and all past, present, or future infringements or dilution of or damage or injury to the mark or the registration thereof or such associated goodwill;

(b) the right to secure registrations therein in the names of MWH Global, Inc., and Michael C. Donaldson as joint owners and to secure renewals and extension of the registrations and applications for registrations in the United States of America or any other country; and

(2) Michael C. Donaldson hereby grants, transfers, assigns, sells, conveys, and relinquishes to MWH Global, Inc., and Michael C. Donaldson, as joint owners, and their respective successors and assigns, the entire title, right, interest, ownership, goodwill, and all subsidiary rights in and to the common law mark WISH WANT WALK including, but not limited to, the following:

(a) the right to sue and recover for, and the right to profits or damages due or accrued arising out of or in connection with, any and all past, present, or future infringements or dilution of or damage or injury to the mark or the registration thereof or such associated goodwill.

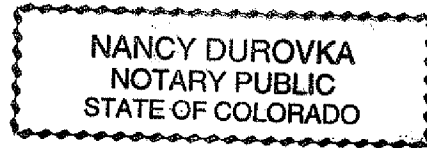
