NOW THEREFORE, for and in consideration of good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sells, assigns and transfers to Assignee, its successors, assigns and legal representatives, the full and exclusive rights, titles and interests in and to all of Assignor's intellectual property, including trademarks (including, without limitation, those specifically enumerated on attached Schedule A), trade names, business names, service marks, brand names, domain names (including, without limitation, those specifically enumerated on attached Schedule B), patents, inventions, know-how, copyrights, trade secrets, registered designs, industrial designs and all other industrial or intellectual property owned or used in carrying on the Business (as set forth in the Agreement) and all applications therefor, all reissues, divisions, re-examinations, renewals, extensions, provisionals, continuations, continuations-in-part and all goodwill connected therewith, including the rights to recover for past, present and future infringement, misuse, misappropriation, and other violations of any of such intellectual property, the right to file applications and obtain patents, utility models, industrial models and designs for the inventions throughout the world, all rights of priority under international treaties and conventions arising from applications for patent, all rights to publish cautionary notices reserving ownership in any inventions, and all rights to register said inventions and patents thereon in appropriate registries.
