BETWEEN

1. **Doncasters Limited**, a British company of 28-30 Derby Road, MELBOURNE, Derbyshire DE73 8FF United Kingdom (hereinafter referred to as "Doncasters") and
2. **Doncasters Medical Technologies Limited**, a British company of 28-30 Derby Road, MELBOURNE, Derbyshire DE73 8FF United Kingdom (hereinafter referred to as "DMT")

RECITALS

- A. Whereas Doncasters is the registered applicant or joint applicant in respect of patent applications further details of which are in Schedule 1 hereto (hereinafter called the "Patent Applications")
- B. Whereas Doncasters is the registered proprietor in respect of certain trade mark registrations further details of which are in Schedule 2 hereto (hereinafter called the "Trade Marks")
- C. Whereas Doncasters and DMT are part of a group of companies ultimately sharing the same common ownership and DMT has overall responsibility for the medical business of such group in relation to the inventions resulting in the Patent Applications and the use of the Trade Marks
- D. Now the parties have agreed to execute this Assignment so that the Patent Applications, the inventions claimed in the Patent Applications (hereinafter called the "Inventions" and the Trade Marks are vested in DMT

NOW IT IS HEREBY AGREED AS FOLLOWS:

1. Doncasters hereby assigns to DMT and DMT hereby accepts an assignment of Doncasters' entire right title and interest in and to the Patent Applications, the Inventions and the Trade Marks including without limitation:
 - a. Doncasters' entire right to be absolutely or jointly entitled to any patent granted on any of the Patent Applications for the full term of such patents and its entire right to apply for, be granted and hold patents, jointly or otherwise, for the Inventions in or for any part of the world (including without limitation its right and title to any and all future foreign or PCT applications and national/regional phase applications patents derived from any of the Patent Applications and all future PCT applications as well as

- any and all divisional and continuation applications) and the right to priority from the Patent Applications;
- b. the right to recover and take all such proceedings as may be necessary for the recovery of damages or other forms of relief in respect of all infringements of the Patent Applications and/or the Trade Marks whether committed before or after the date of this Assignment; and
 - c. all goodwill attached to the Trade Marks.
2. The Assignments in paragraph 1 above is without prejudice to the rights of any third party with which any of the Patent Applications may be jointly owned by Doncasters and DMT accepts assignment of such Patent Applications together with the rights and obligations of Doncasters in relation to such joint ownership.
 3. Doncasters hereby agrees that it will at the expense of DMT, promptly execute and sign all such instruments applications documents and do all such acts and things as may reasonably be required by the DMT to enjoy the full benefit of the property and rights hereby assigned (including without limitation executing any and all forms required in connection with the filing and prosecution of patent applications and otherwise assisting with the prosecution to grant of the Patent Applications and any future applications claiming priority or derived therefrom)
 4. This Agreement shall be governed by and interpreted in accordance with the laws of England and the parties hereby submit to the exclusive jurisdiction of the English courts

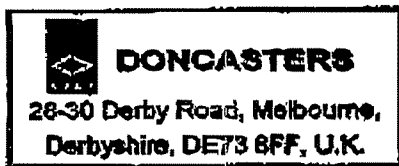
