**ARTICLES OF ORGANIZATION  
OF  
CORRAL WEST RANCHWEAR, LLC**

1. **Conversion.** Upon unanimous approval of all of the shareholders, Corral West Ranchwear, Inc., a Wyoming corporation, was converted to Corral West Ranchwear, LLC, a Wyoming Limited Liability Company.

2. **Former Name.** The former name of Corral West Ranchwear, LLC, was Corral West Ranchwear, Inc.

3. **Original Formation.** Corral West Ranchwear, Inc., was formed in Wyoming on January 3, 1966.

4. **Shareholder Approval.** The conversion of Corral West Ranchwear, Inc., to Corral West Ranchwear, LLC, was approved by a unanimous vote of all of the shareholders of Corral West Ranchwear, Inc.

5. **Name.** The name of the company shall be Corral West Ranchwear, LLC.

6. **Duration.** The period of the company's duration is perpetual.

7. **Purpose.** The purpose for which the company is organized is to engage in any lawful act concerning any and all lawful business, other than banking or insurance, for which a limited liability company may be organized under the laws of the State of Wyoming.

8. **Registered Agent.** The name and address of the company's registered agent in Wyoming is

9. **Property Contributed.** The total amount of cash contributed by the organizational member as capital is the equity in Corral West Ranchwear,

Inc., on the effective date of the conversion from a corporation to a limited liability company. The agreed value of property other than cash contributed to the company is \$0.

10. **Additional Contributions.** The total additional contributions agreed to be made by all members and the times at which or events upon the happening of which they shall be made: None.

11. **Status.** Pursuant to Wyo. Stat. § 17-15-107(x), the company elects status as a flexible limited liability company, and the company, therefore, is authorized to adopt provisions within its Operating Declaration as authorized by Wyo. Stat. § 17-15-144.

12. **Sole Member.** The sole member of the Company is CWR Holdings, Inc., a Wyoming corporation.

13. **Additional Members.** The member of the company has the right to admit additional members from time to time, upon additional terms and conditions of admission as may be further determined by the member at the time of admission.

14. **Right to Continue Business.** In the event of death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the limited liability company, then by unanimous consent the remaining members of the company have the right to continue the business of the company, at their election and option.

15. **Management.** The limited liability company is to be managed by a manager or managers. The name and address of the manager who shall serve as manager until the first annual meeting of the member(s) or until his successor has been elected and qualified is:

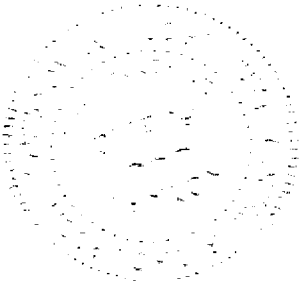
