


The undersigned, Louis Marinaccio, hereby certifies that:

1. He is the Vice President and Secretary of California Day-Fresh Foods, Inc., a corporation organized and existing under the laws of the State of California (hereinafter, the "Corporation").
2. Articles ONE and SIX of the Articles of Incorporation of the Corporation are amended to read as follows:
 - "ONE: The name of this corporation is:
Naked Juice Co. of Glendora, Inc."
 - "SIX: The number of directors of this corporation shall be two (2) until changed by an amendment or restatement of these Articles of Incorporation."
3. The foregoing amendment of the Articles of Incorporation has been duly approved by the Board of Directors of the Corporation.
4. The foregoing amendment of the Articles of Incorporation has been duly approved by the required vote of shareholders of the Corporation in accordance with Section 902 of the Corporations Code. The total number of outstanding shares of common stock of the Corporation is 900. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than 50%.
