**TERMINATION OF PATENT AND TRADEMARK COLLATERAL ASSIGNMENT
AND SECURITY AGREEMENT**

WHEREAS, Home Market Foods, Inc. ("HMF"), a Delaware corporation and successor in interest by merger to The Kentucky Backwoods, Inc. ("KBI") having an address of 140 Morgan Drive, Norwood, Massachusetts 02062, is the owner of certain trademarks, trademark applications, and registrations and the goodwill of the business associated therewith (the "Trademarks"); and

WHEREAS, pursuant to a certain Trademark and Patent Security Agreement dated October 5, 2000, between KBI and General Electric Capital Corporation, a corporation with offices located at 40 Old Ridgebury Road, Danbury, Connecticut 06810 ("GE Cap"), KBI granted to GE Cap a security interest in and to the Trademarks listed on Schedule A annexed hereto and made a part hereof (the "KBI Trademarks"); and

WHEREAS, the parties now desire to terminate GE Cap's security interest in all of the Trademarks.

NOW, THEREFORE, in consideration of the foregoing and of the mutual promises and other good and valuable consideration and intending to be legally bound hereby, GE Cap hereby agrees as follows:

1. The Trademark and Patent Security Agreement dated October 5, 2000, between KBI and General Electric Capital Corporation is hereby terminated and is of no further force or effect.
2. GE Cap hereby releases its security interest and assigns to HMF all of GE Cap's interest in and to all of the KBI Trademarks and the goodwill associated therewith.
3. GE Cap authorizes HMF and/or its attorneys to execute such releases, assignments, statements or other documents, as may from time to time be determined to be reasonably necessary, to release and/or assign any and all liens or interests of GE Cap in the KBI Trademarks.

IN WITNESS WHEREOF, the undersigned has executed this Termination of Patent and Trademark Collateral Assignment and Security Agreement as of this 1st day of March, 2007.
