ARTICLES OF CONVERSION OF
BACKYARD VENTURES, INC.
INTO
BACKYARD VENTURES, LP

ARTICLE 1

The undersigned officer of Backyard Ventures, Inc., certifies the following:

a. Backyard Ventures, Inc. (the "Converting Entity") is a Texas business corporation, incorporated under the Texas Business Corporation Act.

b. A Plan of Conversion has been duly approved and adopted according to the requirements of:

- (1) Article 5.03 of the Texas Business Corporation Act,
- (2) any other laws under which Backyard Ventures, Inc. is incorporated, and
- (3) its constituent documents, to the extent applicable.

The Plan of Conversion provides for the conversion of the Converting Entity to Backyard Ventures, LP, a Texas limited partnership (the "Converted Entity").

c. An executed Plan of Conversion is on file at the principal place of business of Backyard Ventures, Inc. at 103 NW 3rd St., Dimmitt, TX 79027. The executed Plan of Conversion will be on file, from and after the conversion, at the principal place of business of Backyard Ventures, LP, at 103 NW 3rd St., Dimmitt, TX 79027.

d. A copy of the Plan of Conversion will be furnished by Backyard Ventures, Inc. (before the conversion) or by Backyard Ventures, LP (after the conversion), on written request and without cost, to any shareholder of Backyard Ventures, Inc. or to any general partner or limited partner of Backyard Ventures, LP.

ARTICLE 2.

The number of outstanding shares of Backyard Ventures, Inc. entitled to vote on the Plan of Conversion is 48,500. The number of outstanding shares voting for the Plan of Conversion was 48,500, and the number of outstanding shares voting against the Plan of Conversion was 0.

ARTICLE 3.

Two copies of the Certificate of Limited Partnership of Backyard Ventures, LP, which is to be created pursuant to the Plan of Conversion, are being filed with the Secretary of State with these Articles of Conversion.
