RELEASE OF SECURITY INTEREST

This Release of Security Interest, dated as of 2/28, 2007, is made by HNC INVESTMENTS, LLC, successor-in-interest to HF6, INC. (collectively, "Grantee"), in favor of HALSTON LLC ("Halston").

WHEREAS, on November 29, 1999, Halston and Grantee entered into a certain Security Agreement (the "Security Agreement") which provided for the grant by Halston to Grantee of a security interest in the trademarks described on the attached Schedule A, (the "Marks") owned by Halston; and

WHEREAS, on January 6, 2000, Grantee recorded in the Patent and Trademark Office, U.S. Department of Commerce at Reel/Frame 2010/0658, the Security Agreement, evidence of its security in the Marks.

WHEREAS, Grantee, hereby confirms that the security interest in all the Marks has been discharged, terminated and released in all respects.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, Grantee hereby (1) releases, discharges and relinquishes its security interest in and lien on all of the Marks, as listed on Schedule A, and (2) reassigns to Halston all right, title, and interest that Grantee may have had in and to the Marks, including all goodwill of the business associated with the Marks, and the applications for and registrations thereof, and all renewals and extensions thereof, and any and all causes of action for infringement thereof, and any and all royalties for any licenses thereof. Grantee specifically acknowledges that the Security Agreement is no longer effective as to the Marks, and that Grantee does not own any rights to or have any ownership interest or claim in any of the Marks.

Grantee acknowledges and confirms that the terms and conditions of this Release of Security Interest shall be effective evidence of the release of the security interests in the Marks.
