TRADEMARK ASSIGNMENT AGREEMENT

1. Within ten days of execution of this Agreement, Assignee shall pay three thousand US dollars (US\$3,000) to Assignor as consideration for assignment of the Registration;

In consideration of the sum of three thousand US dollars described in paragraph 1 of this Agreement, Assignor hereby assigns unto Assignee its right, title and interest in and to the said mark in the United States, together with the goodwill of the business symbolized by the mark, and the Registration thereof;

4. Assignee will, at its own costs, file recordation of this trademark assignment agreement with the United States Patent and Trademark Office Assignment Division.


7. Nothing in this Agreement will be construed as a license back to Assignor to continue

using the "Stallion" trademark in the United States; and

This Agreement constitutes the entire agreement between the parties with respect to the subject matter thereof, and replaces and supersedes any prior oral or written agreements or representations made by or between the parties involving the same. The invalidity of any provision of this Agreement shall in no way affect the validity of any other provisions. This Agreement may be executed in counterparts, including facsimile copies, each of which shall be deemed to be an original. The parties agree to cooperate fully and to execute any and all supplementary documents, and to take all additional actions that may be necessary or appropriate to give full force and effect to the terms and intent of this Agreement.
