THIS DEED is made on

BETWEEN

- (1) Courtaulds Textiles (Holdings) Limited registered number 01753996, whose registered office is at 225 Bath Road, Slough, Berkshire, SL1 4AU (the "Assignor"); and
- (2) Magellan Textile Holdings Limited, a Hong Kong Corporation, whose address is 1608-1611, 16/F, Tower 2, The Gateway, 25-27 Canton Road, Tsimshatsui, Kowloon (the "Assignee")

BACKGROUND

- (A) The Assignor is the registered proprietor of the registered trade marks detailed in Schedule 1 ("the Registered Trade Marks").
- (B) The Assignor is the proprietor of the trade mark applications detailed in Schedule 2 ("the Applications").
- (C) The Assignor has agreed to assign the Registered Trade Marks and the Applications (collectively "The Trade Marks") to the Assignee on the terms and conditions set out in this Deed.
- (D) The Schedule to this Deed forms part of this Deed and will have the same force and effect as if expressly set out in the body of this Deed and any reference to this Deed will include the Schedule.

1. ASSIGNMENT

- 1.1 By way of an agreement between the Assignor and the Assignee dated 8 May 2006, the Assignor assigns Trade Marks to the Assignee together with all of the Assignor's rights and interests in respect of them.
- 1.2 The Assignor undertakes to do any and all acts and execute any and all documents in such manner and at such locations as may be required by the Assignee in its sole discretion in order to protect, perfect or enforce any of the rights granted or confirmed to the Assignee pursuant to this Deed.

2. MISCELLANEOUS

- 2.1 This Deed and all representations, obligations and warranties contained in it shall enure for the benefit of the successors and assignees of the parties.
- 2.2 The parties to this Deed do not intend that any of its terms will be enforceable by virtue of the Contracts (Rights of Third Parties) Act 1999 by any person not a party to it.

2.3 The formation, existence, construction, performance, validity and all aspects whatsoever of this Deed or of any term of this Deed will be governed by the law of England and Wales.

2.4 The courts of England and Wales will have exclusive jurisdiction to settle any disputes that may arise out of or in connection with this Deed. The parties irrevocably agree to submit to that jurisdiction except that each party may seek injunctive relief in any court of competent jurisdiction.

This document is executed as a deed and delivered on the date stated at the beginning of this document.


