ASSIGNMENT OF TRADEMARK

ASSIGNMENT OF TRADEMARK, dated as of February 28, 2007, by and between Thomas Weisel Partners Group, Inc., a Delaware corporation ("TWPG"), Thomas Weisel Partners LLC, a Delaware limited liability company ("TWP"), and Anián LLC, a Delaware limited liability company ("Anián") and together with TWPG, TWP, the "Assignor", and Reuters S.A., a Societe Anonyme, organized under the laws of Switzerland, having its principal place of business at 153 Rue de Thonon, Geneva, Switzerland (the "Assignee").

WHEREAS, Assignor wishes to convey all of its right, title and interest in and to the Trademarks to Assignee;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:




