RELEASE OF SECURITY INTEREST

This Release of Security Interest (the "Release") is made this ~~29th~~ of January, 2007 by PNC Bank, National Association, as agent (in such capacity "Agent") for the Banks (as defined in the Credit Agreement described below) in favor of Metrologic Instruments, Inc., a New Jersey corporation ("Metrologic").

RECITALS:

A. WHEREAS, Agent was granted a security interest in the assets of Metrologic and Adaptive Optics Associates, Inc. a Delaware corporation ("Adaptive" and together with Metrologic, "Pledgors" and each individually a "Pledgor") in connection with that certain Credit Agreement, dated January 8, 2001, by and among Pledgors, Agent and the Banks (as amended, restated, supplemented or otherwise modified, the "Credit Agreement").

B. WHEREAS, in connection with the Credit Agreement, Pledgors and Agent entered into a Patent, Trademark and Copyright Security Agreement, dated January 8, 2001 (the "IP Security Agreement"), and a Supplement to Patent, Trademark and Copyright Security Agreement, dated March 20, 2003 (the "Supplement").

C. WHEREAS, the IP Security Agreement was filed with the United States Patent and Trademark Office, Patent Division, on February 12, 2001, at Reel/Frame 011511/0142, and the Supplement was filed with the United States Patent and Trademark Office, Patent Division, on April 4, 2003 at Reel/Frame 013868/0090, for the patent assets of the Pledgors, including but not limited to those patents listed on Schedule A hereto.

D. WHEREAS, the IP Security Agreement was filed with the United States Patent and Trademark Office, Trademark Division, on February 12, 2001, at Reel/Frame 2239/0424, and the Supplement was filed with the United States Patent and Trademark Office, Trademark Division, on April 4, 2003 at Reel/Frame 2706/0759, for the trademark assets of the Pledgors, including but not limited to those trademarks listed on Schedule B hereto.

E. WHEREAS, in accordance with the provisions of the Credit Agreement and the IP Security Agreement and Supplement, Pledgors have repaid all obligations due and Agent has terminated and released its security interest in all assets, including all intellectual property of the Pledgors.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent agrees as follows:

1. Agent hereby expressly confirms the termination and release to Pledgors of its security interest in and to all intellectual property of the Pledgors, including but not limited to each patent and patent application listed on Schedule A and each trademark and trademark application listed on Schedule B hereto.
2. Metrologic authorizes and requests that the Commissioner for Patents and the Commissioner for Trademarks and any other applicable government officer record this Release.
