**ASSIGNMENT
(U.S. Trademark)**

WHEREAS, Electro Source, LLC, a California Limited Liability Company, with an address of 14144 Ventura Blvd., Suite 200, Sherman Oaks, CA 91423 ("Electro Source"), (hereinafter referred to as Assignor), acquired by assignment the Mark and registration therefor set forth in SCHEDULE 1; and

AND FOR THE SAME CONSIDERATION, the Assignor also hereby covenants and agrees that, at the time of execution and delivery of these presents, the Assignor is the sole and lawful owner of the entire right, title, and interest in and to the said registration and believes it is the sole and lawful owner of the entire right, title, and interest in and to said Mark and said goodwill associated therewith and that the same are unencumbered and that the Assignor has good and full right and lawful authority to sell and convey the same in the manner herein set forth;

AND FOR THE SAME CONSIDERATION, the Assignor hereby covenants and agrees that the Assignor will sign all papers and documents; deliver necessary documents including original registration certificates; all records of financial, manufacture and promotional transactions and correspondence related to the use of the mark in commerce; the inventory of all goods bearing the mark in the possession of Assignor; and do all acts reasonably necessary or desirable to be done for the procurement, maintenance, enforcement, and defense of said Mark and registration thereof without charge to the Assignee, its successors, legal representatives, and assigns.

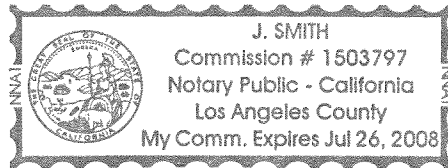

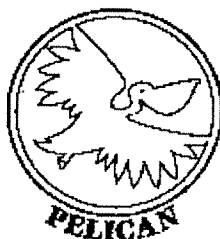
