
**ASSIGNMENT OF TRADE-MARKS**



The Assignor agrees that, at the request and expense of the Assignee, the Assignor will execute and deliver to the Assignee such further documents as may be reasonably necessary to allow the Assignee to record this assignment and to protect and enforce its rights in the Trade-marks.
