
Ladies and Gentlemen:

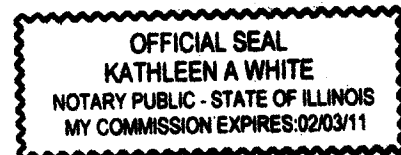
