**TERMINATION OF TRADEMARK SECURITY
AND PLEDGE AGREEMENTS**

WHEREAS, Home Market Foods, Inc. ("HMF"), a Delaware corporation and successor in interest by merger to The Kentucky Backwoods, Inc. ("KBI") having an address of 140 Morgan Drive, Norwood, Massachusetts 02062, is the owner of certain trademarks, trademark applications, and registrations and the goodwill of the business associated therewith (the "Trademarks"); and

WHEREAS, pursuant to certain Trademark Security and Pledge Agreements dated May 20, 2003 and February 28, 2003 ("KBI TSP Agreement"), between KBI and Economic Stabilization Trust, a Massachusetts quasi-public agency with a principal office of 529 Main Street, Suite 110, Boston, Massachusetts 02129 ("EST"), KBI granted to EST a security interest in and to the Trademarks listed on Schedule A annexed hereto and made a part hereof (the "KBI Trademarks"); and

WHEREAS, pursuant to certain Trademark Security and Pledge Agreements dated May 20, 2003 and February 28, 2003 ("HMF TSP Agreement"), between HMF and Economic Stabilization Trust, a Massachusetts quasi-public agency with a principal office of 529 Main Street, Suite 110, Boston, Massachusetts 02129 ("EST"), HMF granted to EST a security interest in and to the Trademarks listed on Schedule B annexed hereto and made a part hereof (the "HMF Trademarks"); and

WHEREAS, the parties now desire to terminate EST's security interest in all of the Trademarks.

NOW, THEREFORE, in consideration of the foregoing and of the mutual promises and other good and valuable consideration and intending to be legally bound hereby, EST hereby agrees as follows:

1. The KBI TSP Agreement and HMF TSP Agreement are each hereby terminated and are of no further force or effect.
2. EST hereby releases its security interest in and assigns to HMF all of EST's interest in and to all of the KBI Trademarks and the goodwill associated therewith.
3. EST hereby releases its security interest in and assigns to KBI all of EST's interest in and to all of the HMF Trademarks and the goodwill associated therewith.
4. EST authorizes HMF and/or its attorneys to execute such releases, assignments, statements or other documents, as may from time to time be determined to be reasonably necessary, to release and/or assign any and all liens or interests of EST in the HMF Trademarks and in the KBI Trademarks.
