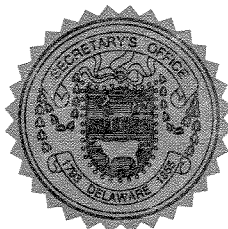

FIRST: That the name and state of incorporation or formation, as applicable, of each of the constituent entities of the merger is as follows:
