WHEREAS, LeMans Corporation, a Wisconsin corporation, having a principal place of business at 3501 Kennedy Road, P.O. Box 5222, Janesville, WI 53547, United States, (hereinafter referred to as "Assignor"), has used the marks: AEROSPEED, BLACKTAIL, BLACKWIDOW, DIAMONDTRAK, FOX A/T, FREAK, MUDFLY, PACTRAX, RAT RADIAL ALL TERRAIN, SAND SNAKE MX, SAND SNAKE MX S, SIDEWINDER, SWAMP FOX, VTRAX, WHIPSNAKE and ZIPPER, all of which marks are used for tires, and filed applications to register the same in the United States and Canada, all as set forth on the attached Exhibit 1 (hereinafter collectively referred to as "the Individual Tire Marks");

WHEREAS, Excel Tire & Wheel Corp., a California corporation, having an office at 21003 Commerce Pointe Drive, Walnut, California, 91788, United States, and 1245 Wedgefield Lane New Albany, Ohio 43054, United States, (hereinafter referred to as "Assignee") and Assignor have been embroiled in a dispute as to which party created, developed and marketed the marks represented by the Individual Tire Marks; and


WHEREAS, Assignor and Assignee have entered into an amicable settlement arrangement regarding the ownership of the Individual Tire Marks; and

WHEREAS, pursuant to the settlement arrangement between the parties, Assignee is desirous of acquiring any and all rights, good will, title and interest Assignor may have in and to the Individual Tire Marks in the United States and Canada, and any and all Applications or Registrations thereof in these countries;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby sell, assign and transfer as of the date set forth below (hereinafter "the effective date") to Assignee, the entire right, good will, title and interest in and to the Individual Tire Marks in the United States and Canada, and any existing applications or registrations therefore in these countries, together with the goodwill of the business symbolized by the Individual Tire Marks in these countries, or with that part of the goodwill of the business connected with the use of and symbolized by the Individual Tire Marks in these countries, including any designs associated with the Individual Tire Marks in these countries, and the right to sue for and recover all damages and other remedies in these countries in respect of any infringement of the Individual Tire Marks which may have occurred prior to the effective date of this Assignment.
