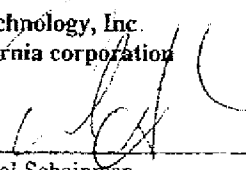

The Secretary of State shall mail any such process to the surviving corporation at 170 West Tasman Drive, San Jose, California 95134 Attn: General Counsel.
