**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

This TERMINATION AND RELEASE, dated as of March 2, 2007, is made by BANK OF AMERICA, N.A., in its capacity as Collateral Agent (the "Collateral Agent") for the Secured Parties under the Security Agreement, dated as of June 22, 2006 (the "Security Agreement") among Lakes Entertainment, Inc. and Lakes Game Development, LLC (collectively, the "Grantors"), and the lending institutions from time to time party thereto and the Collateral Agent.

**WITNESSETH**

WHEREAS, pursuant to the Trademark Security Agreement, recorded with the U.S. Patent and Trademark Office on July 6, 2006 at Reel/Frame No. 3342/0636, the Grantors granted the Collateral Agent a lien on and security interest in and to all of its right, title and interest in, to and under the Trademarks (as defined in the Trademark Security Agreement), including all goodwill associated with such trademarks, and proceeds of any and all of the foregoing;

WHEREAS, the Collateral Agent acknowledges full payment, complete performance and satisfaction of all obligations pursuant to the Agreement secured by the Security Agreement have been made;

WHEREAS, the Grantors have requested that the Collateral Agent release its security interest in the Intellectual Property Collateral, as defined in the Security Agreement in connection with the termination of the Agreement, and the Security Agreement (the "Released Collateral").

NOW, THEREFORE, in consideration of the foregoing, the Collateral Agent hereby RELEASES, without recourse, all of its security interest in the Intellectual Property Collateral, listed on Schedule I attached hereto and incorporated herein by reference, and any other collateral described in the Trademark Security Agreement.

The Collateral Agent agrees to provide the Grantors with any information and additional authorization necessary to effect the release of its security interest in the Released Collateral.
