**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
ANESTHETIX, INC.**

Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Business Corporation Act (the "Act"), the undersigned corporation hereby executes and submits for filing with the Department of State, State of Florida these Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is ANESTHETIX, INC. (the "Corporation").
2. ARTICLE I of the Corporation's Articles of Incorporation is hereby amended by deleting the text of ARTICLE I in its entirety and substituting the following in lieu thereof:

**"ARTICLE I
NAME OF CORPORATION**

The name of the corporation shall be:

SGTR, Inc."

3. The Amendment to the Articles of Incorporation of the Corporation (the "Amendment") was adopted by the shareholders of the Corporation, by Unanimous Written Consent on September 7, 2006, the number of votes being sufficient for approval.

4. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain the same.

5. This Amendment shall be effective upon its filing with the Florida Department of State.
