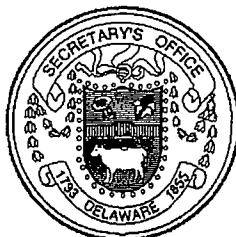

RH&A ACQUISITION CORP., a corporation organized and existing under and by virtue of the Delaware General Corporation Law (the "Corporation"), DOES HEREBY CERTIFY as follows:


**FIRST:** The name of the Corporation is "RH&A ACQUISITION CORP." The Certificate of Incorporation of the Corporation was filed with the Secretary of State of the State of Delaware (the "Secretary of State") on June 30, 2006.
