ASSIGNMENT OF TRADEMARKS AND TRADE NAMES

TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (the "**Agreement**"), between Dairy Queen of Greater St. Louis, Inc., a Missouri corporation located at 1191 Westline Drive, St. Louis, Missouri 63146 ("**Assignor**"), and American Dairy Queen Corporation, a Delaware corporation located at 7505 Metro Boulevard, Minneapolis, Minnesota 55439 ("**Company**"), is effective as of September 27, 2006.

RECITALS

- A. Assignor is the owner of the DIRTY FRIES, Serial No. 75/824,648, Registration No. 2,501,369 (the "**Mark**").
- B. Assignor hereby assigns the Mark to Company pursuant to the Purchase Agreement between Assignor and Company of the same date.

AGREEMENT

In consideration of the above recitals and the promises set forth in this Agreement, the parties agree as follows:

Assignor transfers and assigns to Company all of Assignor's right, title and interest in and to the Mark, together with all associated good will and all related rights, and all registrations and applications for registration of the Mark in the United States and any foreign countries, including any renewals and extensions of any registration that is or may be secured. The provisions of this Agreement inure to the benefit of Company, its successors, assigns and other legal representatives, and are binding upon Assignor, its successors, assigns and other legal representatives.
