WHEREAS, Assignor wishes to convey all of its right, title and interest in and to the Trademark to Assignee; and


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

Assignor does hereby sell, grant, assign, convey and transfer unto Assignee or its designees, all of Assignor's right, title and interest in and to the Trademark, the Registrations and all common law rights related thereto, together with the goodwill of the business connected with the use of, and symbolized by, such Trademark.

Assignor agrees that it shall execute all further documents reasonably necessary to perfect Assignee's title to the Trademark.
