TRADEMARK ASSIGNMENT

THIS ASSIGNMENT is made as of March 2, 2007 ("Effective Date"), between Thriva LLC, a Washington limited liability company, having a place of business located at: 19201 120th Avenue, Suite 102 Bothell, WA 98011 ("Assignor"), and The Active Network, Inc., a Delaware corporation, having a place of business located at 10182 Telesis Court, Suite 300 San Diego, CA 92121 ("Assignee").

WHEREAS, eCamp Messaging Services, Inc. ("Registrant"), a Delaware corporation, located at PO Box 447 Lakeville, CT 06039 adopted, used, and is the owner of record of the trademark "ECAMP" identified by United States Trademark Registration Number 2,686,568 ("Trademark"), which covers goods and/or services described as follows: (i) "PROVIDING MULTIPLE USER ACCESS TO A GLOBAL COMPUTER INFORMATION NETWORK; ELECTRONIC MAIL SERVICES" pursuant to international class 038; and (ii) "PROVIDING COMPUTER SERVICES, SPECIFICALLY TO MAINTAIN WEBSITES FOR OTHERS AND DESIGNING SOFTWARE FOR USE BY OTHERS" pursuant to international class 042. (collectively "Goods & Services").

WHEREAS, Registrant previously assigned all right, title and interest in and to the Trademark, together with the goodwill of the business symbolized by the mark in the above-identified registration thereof, , along with the portion of the business associated with the Goods & Services to which the Trademark pertains as required by 15 U.S.C. §1060, to Assignor pursuant to that certain written Asset Purchase Agreement dated March 6, 2006, by, between and among Thriva, LLC as Buyer on the one hand and eCamp Messaging Services, Inc., Family Link Systems, LLC and Seth Hirschel and Adam Helfgott, collectively as Principals and Seller on the other hand. ("Original Assignment"), but did not record the Original Assignment with the United States Patent and Trademark Office.

WHEREAS, Assignor adopted, used, and has further assigned the Trademark to Assignee and Assignee has acquired all of Assignor's rights in and to the Goods & Services and that portion of Assignor's business associated with the Goods & Services to which the Trademark pertains as required by 15 U.S.C. §1060, the Trademark, and the goodwill of the business symbolized by the Trademark as of the date first stated above, and wishes to have the assignment therefore memorialized in this document.

NOW, THEREFORE, in consideration of the foregoing recitals and such other monetary consideration previously received by Assignor from Assignee and other valuable considerations, Assignor hereby affirms that it has sold, assigned and transferred unto the Assignee all right, title and interest in and to the Goods & Services and that portion of the business associated with the Goods & Services to which the Trademark pertains as required by 15 U.S.C. §1060, the Trademark, together with that part of the goodwill of the business connected with the use of and symbolized by the Trademark and all rights associated therewith, which the Assignor has heretofore enjoyed including the right to sue for past infringement, the same to be held and enjoyed by Assignee, its successors and assigns.

Assignor requests that the certificate of registration of said trademark be issued to and in the name of The Active Network, Inc.
