JOINT TRADEMARK ASSIGNMENT

THIS AGREEMENT is dated as of March 1, 2007.

WHEREAS, Acom Publishing, Inc., a North Carolina corporation and Neofax, LLC, a North Carolina limited liability company (together, the "Assignors"), having a principal place of business at 6116 Chowning Court, Raleigh, North Carolina 27612, have adopted, acquired, used and is using in a substantially exclusive and continuous manner in its business the trademarks listed on Exhibit A attached hereto and made a part hereof (the "Trademarks"); and

WHEREAS, Thomson Healthcare Inc., a Florida corporation ("Assignee"), having its office at Five Paragon Drive, Montvale, NJ 07645, is desirous of acquiring all right, title and interest in and to said Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignors do hereby assign unto Assignee, its successors and assigns, all of their right, title and interest, whether statutory or at common law, in and to the Trademarks, together with all the goodwill of the business symbolized by the Trademarks in the United States and all countries throughout the world, and together with the right to sue and collect damages and/or profits for past infringements of the Trademarks, the intent hereof being to substitute Assignee in the place of Assignors.

Assignors further authorize the Commissioner of Patents and Trademarks of the United States whose duty it is to record trademark registrations, applications and title thereto, to record the Trademarks and title thereto as the property of Assignee, its successors, legal representatives and assigns in accordance with the terms of this Agreement.


Assignors further agree to execute such further documents as may be reasonably required to record Assignee as the owner of the Trademarks and registrations and applications herein assigned, solely at the cost of Assignee.

This Agreement may be executed in several counterparts, each of which shall be deemed an original, but all of which together will constitute one and the same instrument. Counterparts of this Agreement (or applicable signature pages hereof) that are manually signed and delivered by facsimile transmission shall be deemed to constitute signed original counterparts hereof and shall bind the parties signing and delivering in such manner.

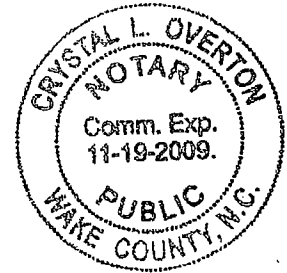

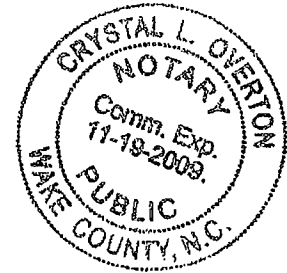


