
TRADEMARK ASSIGNMENT



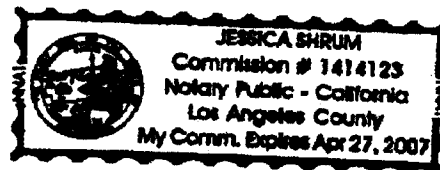
