Release of Lien on Trademarks

Release of Lien on Trademarks, dated as of March 7, 2007 (the "*Release*"), by Credit Suisse, Cayman Islands Branch, as administrative agent under the Credit Agreement for the Lenders (as defined below) (in such capacity, the "*Administrative Agent*"), in favor of MonsterCommerce, LLC (the "*Grantor*").

WITNESSETH:

WHEREAS, Network Solutions, LLC ("*Borrower*") entered into a Credit Agreement, dated as of January 9, 2006 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*Credit Agreement*") with the banks, financial institutions and other entities listed on the signature pages thereof (collectively, the "*Lenders*"), the agents named therein, and the Administrative Agent, pursuant to which the Lenders have made certain commitments, subject to the terms and conditions set forth in the Credit Agreement, to extend certain credit facilities to Borrower;


WHEREAS, pursuant to the terms of a Security Agreement dated as of January 9, 2006, and as further amended, in favor of the Administrative Agent, the Grantor executed and delivered a Grant of Trademark Security Agreement dated as of January 9, 2006, and recorded in the United States Patent and Trademark Office at Reel 3228, Frame 0483, (the "*Trademark Security Agreement*") pursuant to which the Grantor granted to the Administrative Agent a security interest in and lien on all right, title and interest of the Grantor in certain Trademark Collateral (as defined in the Trademark Security Agreement) and as set forth on Schedule A attached hereto (the "*Released Trademarks*") to secure the performance of certain obligations (the "*Obligations*"); and


WHEREAS, the Obligations have now been satisfied, the Grantor has requested that the Administrative Agent release any and all interest it may have in the Released Trademarks, and the Administrative Agent has agreed to do so.

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent does hereby release, relinquish and discharge its security interest in, to and under the Released Trademarks.

IN WITNESS WHEREOF, the Administrative Agent has caused this Release to be duly executed and delivered by its officer thereunto duly authorized as of the date hereinabove set forth.
