
WHEREAS, HFS has satisfied its obligations to PNC, as provided in the Intellectual Property Security Agreement.

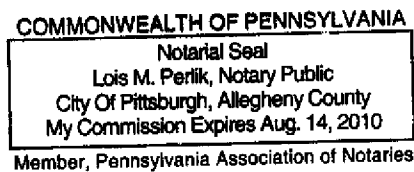
