ASSIGNMENT OF TRADEMARK AND GOODWILL

Assignor agrees, on behalf of itself and any successor, assign, or legal representative, that it will execute and deliver to Assignee, with reasonable compensation, any and all additional documents and perform any further acts reasonably necessary to vest in Assignee the Trademark and the goodwill associated therewith, including, without limitation, executing all documents required to enable Assignee to duly record this Assignment with the United States Patent and Trademark Office and with the equivalent governmental authority of any applicable state.




