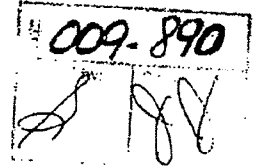

These Articles of Correction of Articles of Amendment of the Certificate of Incorporation of Southern Risk Services, Inc., an Alabama corporation (the "corporation"), prepared in accordance with the provisions of Section 10-2B-1.24 and 10-2B-10.06 of the Code of Alabama (1975), as amended:

1. On February 27, 2002, Articles of Amendment to Articles (Certificate) of Incorporation of Southern Risk Services, Inc. were filed with the Office of the Judge of Probate of Jefferson County, Alabama.

2. The Articles of Amendment provided for an amendment to the certificate of incorporation to change the name of the corporation. These Articles were incorrect and incomplete in that the amendment was incorrectly stated, and the Articles fail to reflect the number of shares voting for the amendment.

3. The Articles of Amendment have been corrected by this document by restating the Articles of Amendment in their entirety to read as follows:

- (a) The name of the corporation is Southern Risk Services, Inc.
- (b) Paragraph 1 of the Certificate of Incorporation of the corporation is amended in its entirety to read as follows:
  1. The name of the corporation is Attenta, Inc.
- (c) The amendment was adopted by the shareholders of the corporation on February 27, 2002.
- (d) The number of shares of capital stock of the corporation outstanding at the time of the adoption of the amendment was 50 shares of common stock; and the number of shares of common stock entitled to vote on the amendment was 50 shares.
- (e) The number of shares of common stock voted for such amendment was 50; and the number of shares of common stock voted against such amendment was 0.


"Article 1 of the Articles (Certificate) of Incorporation is hereby deleted in its entirety and there is substituted in lieu thereof the following:
