Re: Loan and Security Agreement dated January 18, 2002 by and between Misonix, Inc. and Fleet National Bank, as amended. Current loan number 1269661/281.

Dear Mr. Zaremba:

The following is a breakdown of the principal amount, accrued interest and other costs due under the above referenced loan as of December 29, 2006.

In addition, there is currently a Standby Letter of Credit No. 68008745 (the SBLC) issued and outstanding in the amount of \$629,000.00 in favor of Travelers Casualty and Surety Company of America. In order to secure Borrowers' obligation to reimburse Bank of America for any draw under the SBLC Borrowers shall deliver to Bank of America cash collateral in the amount of \$629,000 (the "LC Cash Collateral"). Borrowers hereby acknowledge that they have granted Bank of America a security interest in the LC Cash Collateral. In the event the SBLC is not drawn upon, Bank of America agrees to return the LC Cash Collateral to Borrowers: (a) in the event the original SBLC is not returned to Lender no later than thirty days following the expiry date of the SBLC or (b) within a reasonable lesser amount of time following the return of the original SBLC. Any unpaid letter of credit fees must also be paid.

Bank of America shall release, terminate and satisfy its security interest in all of the collateral securing the Borrower's obligations, and execute and deliver such releases, termination statements or directions to terminate as Borrowers may reasonably request, which must be prepared and filed by Borrowers at Borrowers' sole cost and expense. This will include, but not be limited to, termination of any interest in


any patent and trademarks. Upon confirmation of Bank of America's receipt of the Payoff in the amount of \$2,005,958.86 together with any additional Per Diem interest, if any, along with the deposit of the LC Cash Collateral in the amount of \$629,000, Borrowers are authorized by Bank of America to file UCC termination statements to terminate Bank of America's security interest in Borrowers' personal property collateral, other than Bank of America's security interest in the LC Cash Collateral which shall continue as provided under the terms of this letter.
