RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE is made as of March 8, 2007, by WACHOVIA BANK, NATIONAL ASSOCIATION (“the Secured Party”),

1. Secured Party hereby releases its security interest in the Trademarks originally granted to Secured Party pursuant to the Security Agreement.
2. Secured Party, to the extent granted in the Security Agreement, hereby assigns, grants and otherwise re-conveys to M.G. Digital, all of its right, title and interest in and to the Trademarks and all goodwill associated therewith originally granted to Secured Party pursuant to the Security Agreement.
3. Upon the request of M.G. Digital, Secured Party further agrees to execute all documents necessary to demonstrate and confirm the parties’ intent under this Release of Trademark Security Interest.
