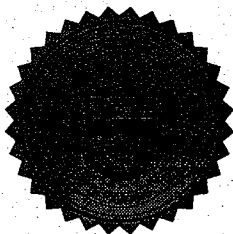

Second: The Certificate of Incorporation of the Corporation is hereby amended by striking Article First and by submitting in lieu thereof the following:


"First: The name of the corporation is WestfaliaSurge, Inc."


