RELEASE OF SECURITY INTEREST (TRADEMARKS)


THIS RELEASE OF SECURITY AGREEMENT (Trademarks) (the "Release") is made and dated this 12 day of March, 2007 by BANK OF THE WEST (the "Lender").

Pursuant to that certain Supplemental Security Agreement (Trademarks) dated as of October 31, 2003 (the "Trademark Security Agreement") between the Lender and JOHNNY ROCKETS LICENSING CORPORATION, a California corporation (the "Company"), the Company granted a security interest to the Lender in certain trademarks to secure obligations of THE JOHNNY ROCKETS GROUP, INC., a Delaware corporation (the "Borrower") to the Lender under the Credit Agreement dated as of October 31, 2003 between the Borrower and the Lender (as amended, extended and replaced from time to time, the "Credit Agreement"). The Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 6, 2003 on Reel/Frame 002743/0377.

At the request of the Borrower, the Lender has agreed to release its security interests in the Trademarks described on Schedule 1 to this Release, and, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the Lender releases and relinquishes any security interest in the Trademark described on Schedule 1 to this Release.
