BETWEEN:

(1) **CELLEGY PHARMACEUTICALS, INC.**, a Delaware corporation having its principal place of business at 2085B Quaker Point Drive, Quakertown, Pennsylvania 18951, U.S.A. including his successors and assigns (the "Assignor"); and

(2) **STRAKAN INTERNATIONAL LIMITED**, a company incorporated under the laws of Bermuda with its principal place of business at Galabank Business Park, Galashiels, TD1 1QH, United Kingdom including its successors and assigns (the "Assignee").

WHEREAS

- (A) The Assignor is the legal and beneficial owner of the trade marks in the USA particulars of which are set out in the Schedule (the "Trade Marks").
- (B) The Assignor has agreed to assign to the Assignee the Trade Marks together with the goodwill of the business of the Assignor concerned in the goods in respect of which the Trade Marks are registered upon the following terms and conditions

OPERATIVE PROVISIONS

IT IS HEREBY AGREED AS FOLLOWS:-

1. In pursuance of the said Agreement and in consideration of the sum of US\$100 (one hundred US dollars) now paid by the Assignee to the Assignor (the receipt and sufficiency of which the Assignor hereby acknowledges) the Assignor with full title guarantee HEREBY ASSIGNS unto the Assignee the Trade Marks and the full and

exclusive benefit of each of them together with the goodwill of the business of the Assignor concerned in the goods or services in respect of which the Trade Marks are registered and the right to sue for past infringements TO HOLD the same unto the Assignee absolutely.

2. The Assignor HEREBY COVENANTS with the Assignee that the Assignor will, at the discretion and expense of the Assignee, execute, sign and do all such instruments, applications, documents, acts and things as may reasonably be required by the Assignee to enable the Assignee (or the nominee of the Assignee) to enjoy the full benefit of the property and rights hereby assigned including enabling the Assignee to become registered as proprietor of the Trade Marks.
3. This Assignment shall be governed by English law.


