all relief to which ASSIGNOR may have been entitled by reason of any such past infringement, said entire right, title, and interest to be held and enjoyed by the JOINT ASSIGNEES for their own use and benefit and for the use and benefit of their successors and assigns, to the full end of the term for which said patents may be granted, as fully and entirely as the same would have been held and enjoyed by said ASSIGNOR had this assignment and sale not been made. The Commissioner of Patents and Trademarks is hereby authorized and requested to issue the Letters Patent which may mature from the aforesaid application to the JOINT ASSIGNEES, as the assignees of said entire right, title, and interest in and to the same.
